Alpena County Clerks Ready for Election

We contacted every Clerk to find out how prepared they are for the upcoming election. They all assured us that they have ample staff and supplies, and have a secure process for Absentee Ballots and Polling locations.

If you have not received your Absentee Ballot, contact your Clerk immediately.

Ballot Boxes are ready to go outside the Clerks' offices. Only Wellington, Ossineke and Long Rapids do NOT have Ballot Boxes, so return your Ballot directly to the Clerk's Office.

Don't worry - all Ballots will be counted on Election Day and each township has procedures to deal with anyone interfering with voting.

If, for any reason, you are concerned about voting in person on November 3rd, call your Clerk asap to request an Absentee Ballot.

THEY'VE GOT THIS!!

Let's do this!! We are 3 weeks out and closing in on THE election of our lifetime. Now is the time to do 1 more thing each day: make 1 more call, plant 1 more sign, offer to drive 1 more person to vote or donate 1 more time. We cannot rest just yet.

Be assured, our local election process is secure. There is lots of noise on the national level, but our Clerks are prepared. Absentee Ballots have been safely received and counted for decades. We urge you to vote this way and, if mailing: **Return your Ballot by October 20TH.**

Remember our elections are local! Polling places are nearby; Clerks know most of us or recognize our names. Neighbors are counting and verifying the Ballots!

With the never-ending irresponsible behavior of Republicans, nationally and statewide, we must vote them out!!!! All our local and state candidates NEED YOUR VOTE!

On the **Democratic Candidates Slate** (p.2) pay special attention to the **Nonpartisan Section** and vote for Judges McCormack, Welch, Rick, and Black!! Voting straight ticket does NOT include the Judges.

Register to Vote at the Clerk's Office

Check to see if you are registered at: www.Michigan.gov/vote. If so, it will give you all the information you need to vote. If you are not registered, CALL YOUR CLERK.

Deadlines: Mail in October 19th Walk in (w/ proof of residency) October 20 – Nov 3rd

Request an Absentee Ballot ASAP

If you have not received your requested Absentee Ballot, CALL YOUR CLERK now!

If you want an Absentee Ballot, call your Clerk to receive an Application which you must fill out and return. Then you will receive the actual Ballot to fill out and return.

3 Ways to Return Your Ballot

1. Hand deliver to Clerk's Office
2. Drop in Ballot Box outside Clerk's office
3. Place 2 stamps on & mail through US Postal Service.

Mail Your Ballot by October 20th to make certain it is received on time.
