Message from the Board...

In deciding to dedicate her full attention and energies to her campaign for the Michigan District 106 State House race, former ACDP chairperson, Marie Fielder, in early August, announced her resignation from the position of ACDP Chair, effective Friday, August 12, 2022. The leadership team of ACDP supported Marie's decision. At the ACDP County Committee Meeting (Membership Meeting) held on August 18, a motion was made to elevate David Dunn, ACDP Vice-Chair, to the position of Acting Chair for the remainder of 2022 and the motion passed unanimously. November 8 election will include 2 hard fought, historic ballot initiatives!

Reproductive Freedom for All, as Proposal 3, would amend Michigan's constitution to guarantee "a fundamental right to reproductive freedom" that includes abortion care, contraception, infertility care and sterilization.

Promote the Vote, as Proposal 2, amends state constitution and includes:

- providing voters with the right to vote without harassment, interference, or intimidation
- guaranteeing that military and overseas ballots postmarked by election day are counted
- requiring a photo ID or a signed affidavit to vote
- authorizing voters to drop off absentee ballots at drop boxes
- allowing for nine days of early voting
- requiring public disclosure of donations from private entities that were used to pay for elections or audits
